Blue Heron Hosts 2001 SR-7A Conclave

Wahunsenakah Lodge #333 sent more delegates to this year's conclave than to any other conclave in our lodge's history. Over 120 Arrowmen from our lodge gathered on Friday, April 27th at Camp Pipsico in Surry, VA to attend this year's conclave, hosted by Blue Heron Lodge #349. Blue Heron Lodge is celebrating its 55th anniversary this year, and this marks the first time since 1996 that a conclave has returned to Camp Pipsico.

After setting up tents in our camp site on Friday night, brothers immediately began to take part in the many activities that the section and the host lodge had planned for us. Some brothers went to the dining hall for a cracker barrel of ravioli and cake. Blue Heron's cooking staff had carefully prepared six sheet cakes, each with a totem of one of the six lodges in Section SR-7A. This was quite an impressive sight to see – before they were eaten! Other brothers spent time on Friday patch trading, going to the trading post, or just fellowshipping with other Arrowmen. Friday night The Patriot was shown outside on a large screen, which brothers enjoyed watching while eating the popcorn and cotton candy available in the dining hall.

Saturday morning began with the Vigil rededication and breakfast, followed by the flag raising ceremony and general announcements. Then, it was off to training. Training was sponsored this year by Wahunsenakah Lodge, and led by our Training CVC, former Lodge Chief Matt Singletary. Training classes ranged in topics from ceremonies, chapter operations, the role of the adviser, and the new Troop and Team Order of the Arrow Representative program.

After lunch at "Tasty Critters" (you had to be there!), Saturday afternoon was spent by Arrowmen competing in the ceremonies, dance team, and sports competitions, or working on carving our lodge's totem pole. For our winners in the competitions, please see the next paragraph.

After the retreat ceremony and dinner, members began to assemble on the field for the shows. Following the awards show, a theme show was presented, which taught us all a lesson that we will remember for a long time. Saturday night was a blast, full again of patch trading and fellowship, as well as a "camp fire" story, a block party, and sumo wrestling!

2002 National OA Conference (NOAC)

The 2002 National Order of the Arrow Conference is just around the corner. It is scheduled for July 27 - August 1, 2002, at Indiana University in Bloomington, Indiana. NOAC is a national event for all Arrowmen. Each day, Arrowmen have the opportunity to receive some of the best training, encounter new adventures, attend Scouting extravaganzas, and see amazing evening shows. It offers a great chance to meet other Arrowmen from around the country, attend and participate in American Indian events and see some memorable museum displays. This is one of the best OA events imaginable. Future issues of Duck Calls will have more information.

OA at the 2001 Nation Scout Jamboree

The National Scout Jamboree will be held July 23-August 1, 2001, at Fort A.P. Hill, Bowling Green, Virginia. The Jamboree will provide over 500 Arrowmen an opportunity to serve Scouting and showcase Order of the Arrow programs for the 38,000 participants at this event held every four years. Arrowmen will be active in four main areas for the Jamboree:

- The American Indian Village will consist of a model campsite and dance arbor where American Indian dance, crafts, regalia construction and games will be demonstrated. The Village will also teach the Indian Lore merit badge.
- The Outdoor Adventure Place (TOAP) is an outdoor skills area where Jamboree participants will learn about "Leave No Trace" build camping. teamwork through participation challenge events, sample outdoor cooking, and see Scouting's entire inventory of outdoor camping gear.
- Scoutopia is an event that centers on providing all attendees the opportunity to visually make the Scout Law come alive in their hearts and minds via a state-of-the-art interactive show.
- The **OA Service Corps** will provide over 150 Arrowmen the opportunity to provide meaningful service to the National Scout Jamboree. Examples of services that will be performed by the Service Corps include ushering at all arena shows, program and administrative support, flag ceremonies, youth recreation opportunities, and VIP guides.

In addition to directly supporting the Jamboree programs, many Arrowmen will serve as troop leaders with their council contingents, or on other Jamboree support staffs. There is no **OA Rendezvous Show** being held at the 2001 National Jamboree. Through many areas, the Order of the Arrow will help make the Jamboree a success!

Under no circumstances should tenure in Scouting or the Order of the Arrow be considered as reason enough for a Vigil Honor recommendation.

Please provide the requested information in as much detail as possible to aid the Vigil Selection Committee in making a determination of who they will recommend to the National Director, Order of the Arrow.

- 4. List Brotherhood date (if known). Nominees must have received Brotherhood at least two years prior to August 30 of the nomination year (i.e. the 2001 nominee must have received Brotherhood no later than August 30, 1999).
- 5. Give the nominee's current primary registered Scouting position.
- 6. List all OA positions which the individual has held or currently holds, (i.e. Chapter/Lodge Officer, Chapter Committee Chairman or Associate Chairman, Chapter/Lodge Adviser or Associate Adviser, etc.). If no positions were held, leave blank. Chapter/Lodge positions are not mandatory for Vigil Honor selection.
- 7. List all other Scouting positions previously held or currently holding excluding the positions listed in (5) and (6) above.
