

The February Ordeal went great with 162 arrowmen in attendance, a considerable amount of work was accomplished and the fellowship was outstanding.


With a lodge like Kecoughtan it is a pleasure to serve as your Chief.



#### O/A ELECTIONS TO BE CONDUCTED BY PROPER METHODS

Each Scout troop in the Peninsula Council is entitled to hold an election to enable qualified Scouts and Scouters to become candidates for membership in the Kecoughtan Lodge. Each Scoutmaster is advised that the only election procedures which are permissible are those described in the current Order of the Arrow Handbook.

The elections must be held by the appropriate Chapter Unit Election Team. If a troop wishes to hold an election, the Scoutmaster is requested to contact the Chapter Chief or Chapter Adviser in the chapter which is located in his troops' district and arrange for the Unit Election Team to hold the election. If this is not done and an election is held by any other means, the election will be declared VOID and will not be accepted by the Kecoughtan Lodge. This will be an embarrassment to the troop and a disappointment to the Scouts who think they were elected. Contact the following:

#### VOTE ON BY LAW CHANGE JUNE 26

A proposed change to Section VIII (The E. Bailey Tudder Campership Fund) has been made and will be voted on at the Ordeal in June.

The present Section VIII, reads as follows:

A. Once each year, at the Winter Ordeal, the lodge shall conduct a patch auction for the registered participants of the Ordeal. The entire proceeds are to be placed in a special fund for the purpose of camp maintenance.


B. At their discretion, the Lodge Service Committee Chairman, with the concurrence of the Service Committee Adviser and the Lodge Adviser, amy authorize expenditures from the fund, provided the funds are utilized strictly for the maintenance of presently built or installed items at camp and new capital projects are not initiated.

The new Section VIII after change will read as follows:

- A. Once each year, at the Winter Ordeal, the lodge shall conduct a patch auction for the registered participants of the Ordeal. The entire proceeds are to be placed in a special fund, the purpose of which is to provide financial aid for Scouts who require it in order to attend Camp Chickahominy Summer Camp.
- B. The fund may receive donations from other sources and use them for the purpose stated in paragraph A. above.
- C. The fund, in its entirety, will be administered jointly by the Lodge Chief, The Chairman of the Lodge Camping Promotion Committee, and the Peninsula Council Boy Scout Committee.
- D. The fund, upon passage of this amendment, assume half the assets and liabilities of "The E. Bailey Tudder Camp Maintenance Fund" which will thereby no longer exist. Total money obtained at the 1988 Winter Ordeal will be put into the Campership Fund.

The reason for the change is that when the E. Bailey Tudder Fund was established it was for camperships. When money for maintenance was not available the fund was changed to provide money to maintain camp facilities. Now with a active property committee and money available for maintenance, the time has come to revert to the original reason for the fund...Camperships.


# MATTAPONI

A chapter meeting was held on March 1st at Temple Baptist Church, I am sorry more of you did not attend, and I apologize to those of you who were not notified.


For those of you not serving on a lodge or chapter committee we have a job for you. If you are interested in helping on a committee call Chapter Chief Bryan Hunt (877-8242).

#### KECOUGHTAN ARROWMEN ATTEND WORLD JAMBOREE

This first hand account
of the 1988
World Jamboree was written
by Vice Chief, David Bains

On the nineteenth of December, four boys from the Peninsula Council left from Richmond's Byrd Airport for Melbourne, Victoria in Australia. Three thousand other Scouts and Scouters from all over the United States also left about the same time headed for Melbourne or other cities in Australia and New Zealand to begin a week and a half of touring prior to the week and a half World Scout Jamboree.

David Bains, Bryan Hunt and Daniel Reisbick were assigned to Troop 521 made up of Scouts from Virginia and North Carolina. It was one of the eleven troops from the Southeast Region. We spent three nights in Melbourne staying at the University of Melbourne, where we began to enjoy the Australian summer. During the day we went on trips to various sites in the Victorian countryside around Melbourne.

On Christmas Eve we flew up to Sydney where we met our host families for Christmas. All of us enjoyed a typical Australian Christmas, which included going to the beach or at least swimming on Christmas Day. David and Daniel stayed with the family of Byron Bramah, formerly a member of Troop 29 in Hampton and Kecoughtan Lodge. Byron and his family lived in Hampton while his father, a colonel in the Australian Army was serving as liaison to TRADOC at Fort Monroe.

The day after Christmas we again boarded a bus and rode off to Australia's most unique national capital, Canaberra. It is an entirely planned city in the middle of the Australian Bush. After an afternoon of sightseeing including the War Memorial and Museum, we went to the U. S. Embassy, built in the Williamsburg style, for a tour and an address by the ambassador.

The next morning it was back to Sydney for an afternoon flight to Auckland, New Zealand. We spent two days there visiting caves, a Maroi Marae, and the thermal valley of Rotorua. The night of December 29, we had home hospitality stays in a dairy farm area. Our stay there was brief for we had a morning flight back to Sydney.

After an afternoon of touring Sydney, the entire Boy Scouts of America contingent met for the only time for an evening show in a Sydney pavilion.

The next day we arrived at Cataract Scout Park near Wollongong, New South Wales. Fifteen Thousand Scouts, both young men and women, from 90 nations attended the XVI World Jamboree Mondial. At the Jamboree we engaged in many activities from water slides to obstacle courses, and orienteering courses, all with a distinctive Australian flair.

There was of course much trading of patches, neckerchiefs, and even whole uniforms. The American contingent was by far more interested in trading and more prepared to do it than any other contingent. The main sports played at the Jamboree were volleyball, table tennis and cricket. The emphasis on all activities was on mixing internationally. No two troops of the same nation camped in sites adjoining each other, and for most activities international patrols were formed of six Scouts, with only two from the same country.

The Jamboree theme of "Bring the World Together" was certainly accomplished and the memories of feeling of fellowship with the Scouts of many different lands shall remain stronger with me than memories of the Australian sights and culture and long after my suntan has faded.
