

WASHBURN REELECTED CHIEF

OTHER OFFICERS ALSO ELECTED

Mike Washburn defeated David Bains for the office of Chief of the Kecoughtan Lodge, after a late decision to run for the office for a third time.

NEW REQUIREMENTS FOR OA MEMBERSHIP

In a letter dated July 7, 1988 and received in the Peninsula Council on August 4, 1988, the National Committee on the Order of the Arrow changed the membership requirements for induction into the OA. These requirements, which are effective immediately are as follows:

Youth membership shall be under 21 years of age and meet the following requirements:

- (a) Hold the first class Scout rank, as a minimum.
- (b) Have 15 days and nights of camping under the auspices and standards of Boy Scouts of America (Which



includes 6 consecutive days of long term camp) within 2 years prior to election by youth members of the unit to which the youth belongs.

Youth members shall be elected by other youth members in accordance with policies set forth by the national committee of the Order of the Arrow.

All persons under 21 years of age are considered youth members of the Order of the Arrow and shall be elected as candidates for membership based on the youth membership requirements.

Adult membership shall be persons over 21 years of age and they shall be selected as candidates based upon the following:

Adult leaders in units: One adult mat be recommended to the lodge executive committee each year by the unit committee for consideration as a candidate for participation in the induction process provided the following conditions are fulfilled:

(a) Selection of the adult is based upon ability to perform the (CONTINUED ON PAGE THREE)

Dear Arrowmen:


It is a pleasure to serve as your chief for a third term. I have great plans for our lodge this coming year. Once again this year the lodge has great officers representing it.

RULES CHANGED FOR SECTION VIII

A change to Section VIII (The E. Bailey Tudder Campership Fund) has been approved at the June Ordeal.

The old Section VIII, read as follows:

- A. Once each year, at the Winter Ordeal, the lodge shall conduct a patch auction for the registered participants of the Ordeal. The entire proceeds are to be placed in a special fund for the purpose of camp maintenance.
- B. At their discretion, the Lodge Service Committee Chairman, with the concurrence of the Service Committee Adviser and the Lodge Adviser, amy authorize expenditures from the fund, provided the funds are utilized strictly for the maintenance of presently built or installed items at camp and new capital projects are not initiated.

The new Section VIII now reads as follows:

- A. Once each year, at the Winter Ordeal, the lodge shall conduct a patch auction for the registered participants of the Ordeal. The entire proceeds are to be placed in a special fund, the purpose of which is to provide financial aid for Scouts who require it in order to attend Camp Chickahominy Summer Camp.
- B. The fund may receive donations from other sources and use them for the purpose stated in paragraph A. above.
- C. The fund, in its entirety, will be administered jointly by the Lodge Chief, The Chairman of the Lodge Camping Promotion Committee, and the Peninsula Council Boy Scout Committee.
- D. The fund, upon passage of this amendment, assume half the assets and liabilities of "The E. Bailey Tudder Camp Maintenance Fund" which will thereby no longer exist. Total money obtained at the 1988 Winter Ordeal will be put into the Campership Fund.

The reason for the change is that when the E. Bailey Tudder Fund was established it was for camperships. When money for maintenance was not available the fund was changed to provide money to maintain camp facilities. Now with a active property committee and money available for maintenance, the time has come to revert to the original reason for the fund...Camperships.

requisite functions, and not for recognition of service, including current or prior achievement and position..

- (b) The individual will be an asset to the Order of the Arrow due to demon strated skills and abilities which fulfill the purpose of the Order.
- (c) The camping requirements set forth for youth members are fulfilled.
- (d) The adult leader's membership will provide a positive role model for the growth and development of the youth members of the lodge.

Adult leaders in council and district positions shall be recommended to the lodge executive committee by the District Chairman, Council President Scout Executive, or members of the professional staff. All requirements set forth for adult leaders in units will be fulfilled with the exception of the camping requirement which may be waived at the discretion of the lodge executive committee.

Induction of adult members shall be at the discretion of the lodge executive committee.

The significant changes

- All persons under the age of 21 are considered youth members and must be elected as candidates for membership based in the youth membership requirements.
- (2) All adults recommended for induction into the OA must receive approval of the lodge executive committee.

HONOR PATCH



1989 ANNUAL DUES REGISTRATION - \$ 4.00 *

Kecoughtan Lodge operates from computerized records. This is necessary because we have grown to 648 members. We need to insure that our records are up to date in order to have correct data for mail lists and telephone contacts. Please fill in the information requested below and return it to the Lodge with your dues payment.

Dues are \$4.00 per member for 1989, payable prior to December 31,1988. After December 31,1988 a late fee of \$1.00 will be added to the dues payment. For those arrowmen that took their ordeal in September 1988, your dues are paid for the 1989 year.

The Lodge rules were ammended in 1986 to include life membership in the Lodge are as follows:

"Life membership in the Lodge may be obtained for a one time payment of \$35.00. Life membership arrowmen will recieve a plastic life membership card. Mailings of all Lodge events will stop if a life member has not registered for any Lodge event for a period of three years. Mailing of Lodge event notices will continue beyond the three year limit if requested in the writing to the lodge membership secretary. It is the responsibility of the life member to keep the membership secretary informed of address changings."
