# Pamunkey Chapter Wins Iron Duck Award

Wahunsenakah Lodge #333
gathered for its third annual Fall
Fellowship Weekend at Camp
Chickahominy the weekend of
October 27-29, 2000. Around 150
Brothers came out for the
weekend, which became
unseasonably warm on Saturday.

The Pamunkey Chapter sponsored this year's Fall Fellowship. The chairman for the event was Matthew Stearn. The success of the weekend is due, in large part, to the adults from each chapter who volunteered to help run events, cook meals, and referee sporting events so that the boys could enjoy themselves even more.

Saturday morning was filled

with training classes, with topics including Youth Protection, Unit Elections, Lodge Officer Training, Troop/Team OA Repreand Training. Other sentative activities included Saturday volleyball, horseshoes egg tossing, the annual Cracker-Eating contest, mountain biking, archery, and tower climbing.

After eating lunch outdoors behind the Dining Hall, Saturday afternoon saw the annual Iron Duck Competition. It was, as always, a hard fought race, but in the end the Pamunkey Chapter, for the third year in a row, who ran away with the honors. CONGRATULATIONS, Pamunkey Chapter, and to all who took part.

On Sunday, August 27 the membership did not accept the rule change proposal dealing with the method and manner that the Lodge conducts its officer elections. After some discussion, the Lodge Executive Board voted to renew this proposal. The text of the proposed change is as follows:

Replace Section III.A.3. With the following:

3. Each chapter represented by at least one youth member may cast ten (10) votes for each lodge office on all ballots. The Chapter Chief, or his designated representative, must cast the ten votes in proportion to a poll of the chapter members present (in whole votes, not fractions). The Lodge Chief, in consultation with the Lodge Adviser and or Staff Adviser, has final authority to determine any questions about whether a Chapter is officially being represented. Such judgments shall be based on the competent authority, such as written or verbal certification, by the Chapter Chief, Chapter adviser, Chapter Staff Adviser of the Chapter in question. In no case shall adults vote or cast ballots for a chapter. a) A nominee must receive a majority (one vote more than 50%) of the votes cast on a given ballot to be elected (abstentions do not count as votes cast). Where a majority is not achieved, the nominee(s) receiving the least number of votes is (are) dropped and another ballot is taken. This procedure continues until one nominee achieves a majority and is declared elected, or until two ballots in succession result in tie votes and the balloting is declared deadlocked. b) When balloting is declared deadlocked, the officer conducting the election will announce to the voting delegates that one more ballot will be taken to break the tie, and, if another tie results, he shall cast sufficient votes for the nominee of his choice to achieve a majority and declare him elected.

### Wahunsenakah Lodge's Newest Vigil Honor Members

As a Scouter, he is currently an Assistant Scoutmaster and Committee Secretary for Troop 6. He has been the awarded Adult Religious Award in 1998 and has recently completed the Wood Badge program as part of Wood Badge Class SR-237. He has served on the Boy Scout Basic Leadership Training staff from 1998 to the present. Concurrently, he is on the Pack 45 Committee Awards as Chairman where he is also Wolf and Den Bear Leader.

He began his search for the arrow in March 1968, sealing his membership as a Brotherhood member in 1969. As an adult Scouter and member of our Lodge he has consistently

performed cheerful service on the kitchen staff for Ordeal Weekends since 1995.

### Wahunsenakah #333 Lodge Annual Dues for 2001 are Delinquent OA Event Code #72

Wahunsenakah Lodge has a dues structure of \$7.00 per year when the dues are paid on time (November 30 of the year preceding the year for which the dues are assessed). An Arrowman who was previously a member of the Wahunsenakah Lodge and did not pay 2000 dues should pay the delinquent dues for 2000 (\$8.00) and the delinquent dues for 2001 (additional \$8.00) at the same time. On March 1, 2001, members who have not paid their 2000 dues will be removed from the Wahunsenakah Lodge roster.
