#### More about the Ship...

ship is This proud the second amphibious ship to bear the name USS CARTER HALL. The first, LSD 3, earned six battle stars for heroics in World War II and five battle stars for her service in Vietnam.

CARTER HALL (LSD 50) was constructed by Avondale Industries, Inc., in New Orleans, Louisiana. She was launched October 2, 1993, and commissioned September 30, 1995. CARTER HALL and her plankowner crew departed on their first six-month Mediterranean deployment on April 29, 1997.

Her crew completed its UNITAS/WATC deployment in November.

The mission of the Landing Ship Dock (LSD) is to transport and launch loaded amphibious craft and vehicles and crews and embarked personnel in an Amphibious Assault. LSDs also render limited docking and repair service to small ships and craft and act as the Primary Ship (PCS) Control during Amphibious Assaults.

CARTER HALL is a Cargo Variant (CV) of the WHIDBEY ISLAND (LSD 41) class. A significant difference between the two ships is that CARTER HALL's well deck has been shortened from 440 feet to 180 feet. This provides embarked Marines with added vehicle and cargo storage areas. The well deck can hold two Landing Craft Air Cushions (LCAC) and a variety of landing craft and tracked amphibious assault vehicles. CARTER HALL's two-spot flight deck can land and service any helicopter in the Navy and Marine Corps inventory.

LSDs are extremely versatile and have a number of secondary missions. The capability of Naval forces to quickly and effectively extract beleaguered civilians from inhospitable areas has made the Navy and Marine Corps team the force of choice to conduct noncombatant/evacuation operations. CARTER HALL can carry and deliver hundreds of tons of relief materials to victims within hours of arrival on the scene. This capability enables CARTER HALL to serve not only as a ship of war, but as a ship of peace.

### Wahunsenakah Lodge's Newest Vigil Honor Members



As a Boy Scout, he achieved all ranks and became an Eagle Scout in December During his trail to Eagle he fulfilled 2000. Troop leadership roles as Assistant Patrol Leader, Patrol Leader, Troop Chaplain, Senior Patrol Leader, and later as advisor to the troop Senior Patrol Leader. Davis attended Lenhoksin High Adventure Camp in 1995 and 1997, and was on Lenhoksin staff during the summer of 1997. Later Davis was part of the Camp Chickahominy Staff in 1998 and 1999. He attended the Charles L. Sommers High Adventure Camp in 1999. He attended the 1997 National Boy Scout Jamboree at Fort A.P. Hill, Virginia.

Davis was extended the Vigil Honor at the conclusion of his Eagle Award presentation on December 22, 2000 and completed his journey of deep significance immediately thereafter.

Davis has relocated to Arkansas and is attending the University of Arkansas. He continues in Cheerful Service and Leadership as a Vice Chief of Service and Ordeal Master for Wachtschu Mawachpo Lodge #559, serving the Westark Area Council, Fort Smith, Arkansas.

## **Lodge Accepts Rule Change**

On Sunday, February 25<sup>th</sup>, 2001, the membership accepted the rule change proposal dealing with the method and manner that the Lodge conducts its officer elections by a vote of 53-38. The new change is printed below:

Replace Section III.A.3. With the following:

3. Each chapter represented by at least one youth member may cast ten (10) votes for each lodge office on all ballots. The Chapter Chief, or his designated representative, must cast the ten votes in proportion to a poll of the chapter members present (in whole votes, not fractions). The Lodge Chief, in consultation with the Lodge Adviser and or Staff Adviser, has final authority to determine any questions about whether a Chapter is officially being represented. Such judgments shall be based on the competent authority, such as written or verbal certification, by the Chapter Chief, Chapter adviser, Chapter Staff Adviser of the Chapter in question. In no case shall adults vote or cast ballots for a chapter. a) A nominee must receive a majority (one vote more than 50%) of the votes cast on a given ballot to be elected (abstentions do not count as votes cast). Where a majority is not achieved, the nominee(s) receiving the least number of votes is (are) dropped and another ballot is taken. This procedure continues until one nominee achieves a majority and is declared elected, or until two ballots in succession result in tie votes and balloting is declared deadlocked. b) When balloting is declared deadlocked, the officer conducting the election will announce to the voting delegates that one more ballot will be taken to break the tie, and, if another tie results, he shall cast sufficient votes for the nominee of his choice to achieve a majority and declare him elected.

The Pamunkey Chapter has set up an information line using the Daily Press 1-line system. To access this system, you simply dial 928-1111, when you are prompted to enter a four-digit code; you will enter 5813 then just listen. You will receive timely and up to date information concerning the chapter.

#### Service Projects at Ordeals


