Then it was time for the new member's go meet their chapter chief's and here what was going on in their chapter.



We all then circled up and sang the order song and said our good-byes to camp.


This was a very successful order that put us on the right track.







This was the 20th year for this Seminar and I expect it to go on assuming Eswac Huppeday Lodge 560



Looking at Camps used by our Council.

Newport News Council was the name of the Peninsula Council from 1918 to 1929. There were two camps, Camp Powhattan and Camp Washington.

Camp Washington was in existence from 1919 through 1932, but Peninsula Scouts attended only through 1929. Washington was larger of the two camps, and also served the Norfolk Council and the Portsmouth Council (later, together, the Tidewater Council). Newport News Council owned Camp Washington.

The Newport News Council owned Camp Powhattan (and yes they used two T's) at first, then sold to the Roanoke Council, (later Blue Ridge Council) in 1926. Roanoke Council operated Powhattan for another 20 years. During the 1929 through 1935 period, Scouts from the Peninsula attended summer camp there following the sale of Camp Washington to Norfolk Council in 1929.

Following the sale of Powhattan, Peninsula Council (named in 1929) purchased Camp Sherwood in 1935, and Sherwood served as the council's camp through 1941. In 1942, the council purchased Camp Okee in Gloucester County, and operated it until 1964. The Council also purchased Camp James River and camp Hope, two properties for use by black scouts on the Peninsula. Both camps were in operation from 1944 through 1965, at which time Camp Chickahominy was purchased (1964), and a fully integrated camping program was introduced to Peninsula Scouting. Camp Chickahominy has been in operation since. It was also known as Peninsula Scout Reservation, but was dropped

when the two councils (Old Dominion and Peninsula Council merged together to make Colonial Virginia Council in 1992).

Camp Waters was the original camp for the Old Dominion Council. It was in operation from 1927 through 1966, at which time it was replaced by Camp

Siouan. Siouan operated from 1967 through 1992, when the council merged into Colonial Virginia Council.

Colonial Council did many new improvements to the camp, to get it where it is today. The Camp includes 11 camp sites, a dining hall, administration meeting building, health lodge, trading post, rifle, shotgun and archery ranges, COPE course which includes a climbing/rappelling tower, central shower houses, a chapel, an Olympic-size pool and other multi-use buildings and add the Chase Program for high adventure.

Now, in 2004, Camp Chick or CHX, has been sold and a New Camp will open up in 2005 in Middlesex County, for a new riverfront camp to succeed Camp Chickahominy when the longtime James City County location closes its gate for good at the end of this year.

What will the new Camp be named? You can help by giving the council your ideals. The campsites should have the names of the Indian tribe of our council, Kecoughtan, Chanco, Kiskiack, Mattaponi, Pamunkey, Piankatank, Chickahominy, Okee, Powhatan, Siouan and Wendamen.

We will have to wait and see what the Camping Committee and council comes up with. Thanks to Glen Chase, for letting me us his info on his site

A Notice from the Council Camp Relocation



The Colonial Virginia Council is about to enter the most important period in its history. We are at the dawn of a new and exciting time for our council and the programs that we provide for our youth. In 2001 it was announced by U.S. Home Corporation, Inc. that it had purchased two adjacent properties to Camp Chickahominy with the intent to develop a two thousand-unit golf course project in James City County. Upon our review of their site plan it was determined that the impending encroachment upon our camp would literally be a stone's throw from our program areas and therefore negatively impact our camp. Compounding the problem was the fact that due to zoning issues and other county restrictions it was impractical, if not impossible, to relocate our program area to another portion of our property and provide the same level of quality. After recovering from the initial recognition and subsequent shock that Camp Chickahominy could no longer be the venue that our scouts and volunteers demand and deserve, the council board recognized this as a golden opportunity to improve upon the camping experience that we have enjoyed for more than thirty-eight years. Following a lengthy negotiation process, we now have a binding contract to sell our camp to U.S. Home, Inc. with closing to occur later this year. This allows us to conduct one more full season of camping at Camp Chickahominy.

During the sale negotiation process, a property search committee was formed and charged with the difficult task of identifying an available location suitable to replace Camp Chickahominy. Key to this search was the attempt to find a property that would give us the ability to combine the three major components of our camping program at one location--- a great traditional Scout camp; CHASE, our aquatics and sailing program (Chesapeake Bay High Adventure Sailing Experience); and a Cub Scout adventure family camp. After an exhaustive search resulting in the review of more than eighty different properties throughout our region, we are now pleased to announce that we have contracts on two adjacent parcels totaling nearly 300 acres fronting the Rappahannock River in Middlesex County. These properties are located off of U.S. Route 17 in an area known as Bayport near jamaica, VA. This location not only provides us with the potential to build a world class Scout Reservation that combines all components of our program, but it also satisfies our criteria of minimizing the travel time for the vast majority of the families and youth that we serve.

The council realizes that there has been widespread speculation among our valued volunteers and the community-at-large regarding the future of camping within the Colonial Virginia Council. Due to the highly sensitive nature of the sale of Camp Chickahominy and the acquisition of the new properties, these negotiations have had to remain confidential among the council leadership until now. Indeed, some of the specifics must continue to remain confidential until the closing of all properties occurs, but barring any unforeseen difficulties you can be assured that our new camping home will provide us with the natural amenities and remoteness necessary to expand the camping experience of the Colonial Virginia Council into one of the finest in the

country. We have already engaged the national camp engineering office of the Boy Scouts of America for preliminary site planning of the new property, and during 2004 we will be conducting several gatherings with our volunteers to listen to your dreams for this new facility and make sure that we have not overlooked any desires that you might have for our new camp. You are encouraged to begin thinking about these now, and we are planning an open house in the fall for all interested volunteers who wish to view the property.

Although the proceeds from the sale of Camp Chickahominy will be directly channeled into the development of the new camp, the vision that we have for the new Scout Reservation facility will require additional funding beyond those proceeds to incorporate all aspects of the camping program and truly make this new facility the envy of our region for generations to come. We have therefore begun the planning and implementation of the first Capital Campaign that this council has conducted in more than thirty-eight years. Much effort has already gone into this process beginning with the inaugural Steering Committee meeting nearly one year ago. It is anticipated that this fund raising process will have a two-to-three year timeframe for completion, and we are counting on each of you with your valuable contacts to help us "sell the mission" to the community. We have a great story to tell potential benefactors, and with your help we are confident that we can meet or exceed our financial goals.

1. All lodge officers are expected to attend all lodge functions. Lodge functions shall be defined as all Ordeals, Lodge Executive Committee Meetings, Fall Fellowships, and Banquets.

Lodge By-Laws

2. If a lodge officer is not present at three (3) consecutive or five (5) total functions per his term, then he will be considered as "not performing duties to the best of his ability", and will be removed by the Lodge Executive Committee.

3. If an officer is removed, the Lodge Chief will follow procedures as per Section III, Letter C of the Lodge By-Laws, which states, "If the office of Lodge Chief is Addition to Section III vacated, the First Vice Chief shall become the new Lodge Chief. All other vacancies shall be filled by appointment of the Lodge Chief with the approval of the Lodge Executive Committee. Lodge Officers selected in this way must be approved by a majority vote of the members present at a regularly scheduled or called meeting of the Lodge. If the Lodge Executive Committee deems it necessary, the vote may be taken by mail-in ballot, in which event approval will be a majority of the ballots received.
