

Now the work is done and we are all cleaned off and ready to go to the election and elect our new lodge leaders to guide us into 2004-2005 lodge year.






















Spring Ordeal





Amendment to Lodge Rules Addition to Section III Lodge Officer Attendance Policy

- All lodge officers are expected to attend all lodge functions. Lodge functions shall be defined as all Ordeals, Lodge Executive Committee Meetings, Fall Fellowships, and Banquets.
- 2. If a lodge officer is not present at three (3) consecutive or five (5) total functions per his term, then he will be considered as "not performing duties to the best of his ability", and will be removed by the Lodge Executive Committee.
- 3. If an officer is removed, the Lodge Chief will follow procedures as per Section III, Letter C of the Lodge By-Laws, which states, "If the office of Lodge Chief is vacated, the First Vice Chief shall become the new Lodge Chief. All other vacancies shall be filled by appointment of the Lodge Chief with the approval of the Lodge Executive Committee. Lodge Officers selected in this way must be approved by a majority vote of the members present at a regularly scheduled or called meeting of the Lodge. If the Lodge Executive Committee deems it necessary, the vote may be taken by mail-in ballot, in which event approval will be a majority of the ballots received. In either event, the vote must be taken at the next scheduled lodge function."
- **4.** Lodge officers shall be defined as Lodge Chief, First Vice Chief, Second Vice Chiefs (2), Secretary, and Treasurer, as in Section III, Letter A of the Lodge By-Laws.
- In cases of emergencies, absences may be excused. The Key Three of the Lodge will review the reason for the absence and decide whether it be excused or unexcused.
- 6. Addition to Lodge By-Laws as Letter F under Section III, "Lodge Officers, Executive Committee, and Advisors" as follows:
 - All lodge officers are expected to attend all lodge functions. Lodge functions shall be defined as all Ordeals, Lodge Executive Committee Meetings, Fall Fellowships, and Banquets.
 - If a lodge officer is not present at three (3) consecutive or five (5) total functions during his term, then he will be considered as "not performing duties to the best of his ability", and will be removed by the Lodge Executive Committee.
 - If an officer is removed, the Lodge Chief will follow procedures as per Section III.C

going from place to place. Youth and Adults from the city are not used to this hilly terrain. But what a beautifully sight of seeing the sun go down behind the mountains that night.





























After a good night sleep, we went to the flag raising ceremony and breakfast followed by Chapel Service. Now it was time for the 2004 Section Officers Election.

- 2. Know the Admonition, the Sign of Ordeal Membership, and the Handclasp. (If you do not remember them, ask a Brotherhood member either before or at the event you choose to be evaluated for Brotherhood.)
- 3. Remain registered in Scouting and, during a period of at least 10 months after undergoing your Ordeal, strive to fulfill you obligation by continuing and expanding your services to your own unit.
- 4. Remain registered in the Order of the Arrow and keep your dues paid. Be aware that acceptance of Brotherhood membership involves an obligation to the Wahunsenakah Lodge and, therefore, develop a concrete idea of how you plan to fulfill this obligation.
- 5. If, after at least 10 months since undergoing your Ordeal, you feel that you are meeting all of the above requirements and earnestly feel that you are prepared for the Brotherhood, you must either explain the following to the Lodge Brother who evaluates you or you must write a letter to the Lodge Membership Secretary in which you:
 - Explain what you think the Obligation means;
 - Describe how you have been fulfilling this Obligation in your Troop and in your daily life, and how you have used your understanding of the traditions of the Ordeal to aid you in your service.


I have to go now. We are going into town to mail our letters and buy bullets. Don't worry about anything. We are fine. Love, Cole.
